Vincent,

I have reviewed the attached document. The duration of the works is extremely short: estimated to be twelve days. The works are very minor in nature and very limited in extent: involving the repair/reconstruction of the parapet on a section of Ticknock retaining wall over a length of 34m and repair to two small areas of damage to the retaining wall. I agree with the recommendation of Atkins in their report, and I recommend that the following reasoned determination can be made:

“Having performed screening for Appropriate Assessment in respect of the proposed reactive maintenance works detailed in the report entitled TO 334 Munster Bridges Team Maintenance - Ticknock Seawall Repair – AA Screening (Atkins, November 2023), I accept the recommendations of Atkins that the proposed reactive maintenance works, individually or in combination with other plans or projects, would not be likely to have a significant effect on any European site in view of the best scientific knowledge and the site’s conservation objectives. I determine that an Appropriate Assessment of these proposed works is not required, as it can be excluded on the basis of objective scientific information following the screening done that the proposed works, individually or in combination with other plans or projects, will have a significant effect on any European site.”
