

## Notice of proposed project pursuant to Regulation 42(13) of the European Union (Birds and Natural Habitats) Regulations 2011 (S.I. No. 477 of 2011)<sup>1</sup>

### **I. The location, nature and extent of the proposed works**

The locations, natures and extents of proposed routine bridge maintenance works are listed in Table 1 below. Further details on the natures and extents of the proposed routine bridge maintenance works are contained within *TO 334 Munster Bridges Term Maintenance 4 – Natura Impact Statement for Munster Bridges (2023, Year 1)* (Revision 2, WS Atkins Ireland Limited, 12<sup>th</sup> February 2024).

### **I. The possible decisions**

Transport Infrastructure Ireland will determine pursuant to Regulation 42(11) of the European Union (Birds and Natural Habitats) Regulations 2011 (S.I. No. 477 of 2011) and Article 6(3) of the Habitats Directive as to whether or not the proposed reactive bridge maintenance works would adversely affect the integrity of a European site.
